The terms used in this pricelist shall be understood in accordance with the GreenWay terms and conditions of recharging service.

- (1) Applicability of Program ONE shall remain unaffected by this update of GreenWay pricelist.
- (2) Program ENERGIA shall be valid from 19.3.2018 and apply with effect from 1.4.2018.
- (3) The price of the recharging service shall be calculated as sum of (i) price portion based on rate for kWh and (ii) price portion based on rate for minutes. Details of the price calculation, including electric energy measurement, are defined in the GreenWay terms and conditions of recharging service.
- (4) In case of recharging at the stations of the GreenWay group in the Republic of Poland (operator - GreenWay Polska Sp. Z o.o.), prices of the electric vehicle recharging service under the program chosen by the client in the Slovak Republic shall apply.
- (5) Applies to all clients regardless of the service option they have chosen. Additional fee shall be final price including VAT, if applicable registration provides for VAT applicability.
